The *Joy of Art!* program at Hospital for Special Care (HSC) is hosting its 9th Annual Juried Photography Show with an opening reception on Thursday, November 8, 2018 from 5:30 to 7:30 pm. We welcome and encourage you to offer up to two of your works of art for the exhibition, which will run through January 28, 2019. Three prizes totaling \$325 will be awarded this year, honorable mentions may also be awarded at the discretion of the Juror, Heather Whitehouse.

Heather Whitehouse is the Director of Education at the Mattatuck Museum in Waterbury, CT, bringing over 12 years of varied experience in other art museums. Whitehouse is also an exhibiting artist focusing on photography with painted overlays of encaustic medium, finished with collage elements.

The *Joy of Art!* Program was created to help patients to achieve enduring improvements in all aspects of their lives. The program enhances the quality of patients' lives by providing a diverse selection of art for their enjoyment, to strengthen the bond between HSC and the community and to foster relationships with talented artists. ENTRY REQUIREMENTS:

- Photographers may submit one or two; two-dimensional original works of photography (color or black & white).
- We request that photographers have completed the photography within the past 3 calendar years, (2015 to present).
- Prints must be framed.
- **Works must be wired for hanging.** We will not accept artwork that is not wired.
- The **minimum** print size requires at least one dimension of the print must be greater than 9 inches. **Maximum** size is 42 inches (framed) in any direction.
- Photographers may sell their artwork.* Please include the value of work (determined by the photographer) and reflect this information on entry form. *(Please indicate if additional prints are available upon request, with the corresponding pricing.)*
- The *Joy of Art!* committee reserves the right to determine the eligibility of submitted work (no nudes, religious or violent overtones, and minimal photo manipulation).
- Photographers should be present during the Opening Reception on Thursday, November 8, 2018 to accept their award.

SUBMISSION & PICK-UP DATES:

- **Submission:** Friday, November 2 between the hours of 9:00 am and 1:00 pm **or** Monday, November 5 between the hours of 1:00 pm and 6:00 pm at the Hospital for Special Care, Aquatic Center, 2150 Corbin Avenue, New Britain. Works must be hand-delivered with all completed and clearly-written registration forms.
- Works may not be removed until the conclusion of the exhibition on Monday, January 28, 2019.
- **Pick-up:** Works must be picked-up on Monday, January 28 between the hours of 9:00 am and 6:00 pm at the Aquatic Entrance. *(Works not picked up within 30 days will become property of the Joy of Art! program at Hospital for Special Care).*
