The *Joy of Art!* Program at Hospital for Special Care is hosting its 16th Annual Juried Art Competition & Exhibition with an opening reception on Thursday, June 27, 2019 from 5:30 to 7:30 pm. We welcome you to submit two of your works of art for the exhibition, which will run through October 24, 2019. Monetary prizes will be awarded this year; honorable mentions may also be awarded at the discretion of the Juror, Maura O'Shea, Manager of Education Programs at the New Britain Museum of American Art.

Maura O'Shea is an artist, educator and arts entrepreneur. Ms. O'Shea has worked in museums and arts organizations for more than 25 years and has exhibited her work in California, Connecticut and New York. She holds a BFA in painting from the University of Connecticut and is currently the Manager of Education Programs at the New Britain Museum of American Art and the owner/founder of The Art Truck in Glastonbury where she lives with her husband and dog, who is the subject of her current work.

Entry Fee:

\$30 for one submission, \$45 for two submissions.

Entry Requirements:

- Artists may submit up to 2 original works that are 2D rendered in the following media: oil, watercolor, pastel, acrylic, mixed media, pen and ink, drawing or graphics. (No photography or sculptures).
- Size of the piece shall be limited to 42 inches (including a frame) in any direction.
- ***Works must be wired for hanging and securely put together.*** We WILL NOT accept artwork that is not wired. The Joy of Art! Program is NOT responsible for work that falls apart during the course of the exhibition.
- Artists may sell their original artwork or prints of their original artwork. *The hospital will deduct a commission of 25% for artwork sold in the exhibition.* All proceeds support the Joy of Art! program at Hospital for Special Care.
- The Joy of Art! Committee reserves the right to determine the eligibility of submitted works (***no nudes, no Giclée prints, no copyright violations, religious or violent overtones will be accepted.***)
- Artists should be present during the opening reception on June 27 to accept award.

Submission & Pick-Up:

- **SUBMISSION: *Friday, June 21 from 9:00 am – 1:00 pm and Monday, June 24 from 1:00 – 6:00 pm*** at the Hospital for Special Care Aquatic Center Entrance. Works must be hand-delivered with all completed and clearly-written registration forms.
- Works may not be removed until the conclusion of the exhibition on October 24, 2019.
- **PICK-UP: *October 24, 2019 from 9:00 am and 6:00 pm*** at the Aquatic Center Entrance. *Works not picked up within 30 days will become property of the Joy of Art! program at Hospital for Special Care.*
